Substance use patterns are always changing. Drug use waxes and wanes over time, partly due to availability, price, attitudes, access, and the non-medical determinants of health. This brief focuses on nitazenes, tianeptine, and synthetic benzodiazepines. They are not the only emerging substances in the United States, and they may never reach national or regional prominence, but they have shown clear and dramatic increases over the past several years. Reframing Overdose Response Through a Lens of Structural Compassion | July 23 at 10:00 AM

Join this NYSACHO webinar where Erin Russell, MPH, Health Management Associates, will share a reframing of overdose response grounded in structural compassion. Drawing from her article "A Call for Compassion in Overdose Response", published in the *International Journal of Drug Policy*, she explores the overdose continuum of care through journey mapping, highlighting opportunities to reduce harm for everyone involved in overdose events. Erin challenges the overreliance on biomedical and technological interventions, emphasizing that the most necessary response is emotional. Leveraging Technology for Post-Overdose Response Initiatives: Carteret County's Experience with Goldie Health | July 29 at 12:00 PM

Join this NYSACHO webinar to hear from Carteret County, NC, who, like every other county in the nation, faced a serious overdose problem. As a vacation-destination community, Carteret also had visitors overdosing during their stay at their beaches. To address the issue, they launched a post-overdose response team. In less than two years, the overdose death rate dropped by 47% and EMS calls for overdose dropped by 87%. In this webinar, learn about the response team Carteret has deployed and the results achieved. Moms Do Care, an initiative of the Massachusetts Bureau of Substance Addiction Services, offers a trauma-informed, integrated care model that connects women to medical, behavioral health and social services. Central to the program are peer support specialists — women with lived experience who build trust and help participants navigate complex systems of care.
