REMINDER: COSSUP's Reaching Rural: Advancing Collaborative Solutions Initiative | Applications due December 16, 2024

The Institute for Intergovernmental Research (IIR), in partnership with the U.S. Department of Justice's Bureau of Justice Assistance (BJA), the Centers for Disease Control and Prevention (CDC), and the State Justice Institute (SJI), has announced the Reaching Rural: Advancing Collaborative Solutions initiative. This year-long program focuses on learning from rural practitioners and fostering collaboration among rural communities. Participants will receive coaching, engage in workshops, and have access to mentorship and a broad network of rural professionals. At the end of the initiative, participants may apply for an implementation grant to launch projects addressing substance use and misuse among

justice-involved individuals in rural areas.
