## PY24-25 APR



- BEI sent counties PY24-25 non-compliance cases as a reminder of correction action, starting on March 28th, followed by early May and June. Data "cleaning" will occur in July as in previous years.
- BEI sent out the first batch of family outcome surveys the third week of March. BEI also sent files to counties in late March to collect name and address information for children who may have a guardian or who are in foster care. This ensures that the survey is sent to the correct contact. Please return these files by the designated date.
- The Child outcome survey process is anticipated to be available in the Hub in the near future. Counties should continue to work in PERDS until notified otherwise.
- Issues with delay reason dropdowns In the Hub have been identified for indicators 1, 7 and 8C. (This might have been addressed to counties or fixed before this meeting)
- The PY23-24 APR Clarification period started on April 8th. Responses are due April 22nd.
