


CHALLENGES



Launched in October 2024. Stipend payment contingent on up - to - date billing. Providers not billing due to many factors.




Administrative time to create contracts and review invoices. Unsure if Agencies would pass stipend payments to providers.





Understanding that hiring from our current provider pool is not going to make an impact on our waitlists.



Data tracking, financial tracking, reporting to County Administration and Legislature and report out to Board of Health Monthly.





- Hired two County Providers SLP and SIT
- Occupational Therapy waitlist went from 20 children to 0
- Speech Waitlist decreased by 30 children
- Special Instruction waitlist went from 27 to 0
- 5 new Independent Providers Contracted with the State since September 2024
- No providers left during EI Hub Launch
- Added additional 10 Core slots a month (Agency).




