Background

The New York State Association of County Health Officials (NYSACHO) is a not-for-profit association with 501(c)(3) tax-exempt status, representing local health departments (LHDs) in New York State. NYSACHO provides advocacy, training, and technical assistance to LHDs. It is the voice of the state's local public health system working for all New Yorkers to prevent disease and disability, promote health and safety, and protect against public health hazards in the environment.

In line with NYSACHO's mission to support and empower LHDs in their work to promote health and wellness, NYSACHO is committed to providing support to LHDs as they work to address and prevent the health impacts of climate change. To this end, NYSACHO, with support from New York State Department of Health (NYSDOH), intends to offer up to ten (10) awards, up to \$3,000 each, to support local climate change and health adaptation projects.

Application Information

Applicants will submit a project description and proposed project budget, using the Application Template in Appendix A. Examples of climate health and adaptation projects are provided in Appendix B. Complete applications should be submitted electronically to Danielle Pellino (dpellino@nysacho.org) by Friday, December 19, 2025, with the email subject line: "2026 Climate and Health Grant Application." All applicants will be notified of their selection status by Friday, January 30, 2026.

Eligibility

To be considered for this funding opportunity, applicants must be a local health department based in the State of New York. If a local health department believes another county government agency may be an appropriate recipient for these funds, they may invite them to apply and should notify Danielle Pellino (dpellino@nysacho.org).

Scoring & Evaluation

NYSACHO and NYSDOH will use the following criteria to review and score applications materials:

- **Project Description (50 points):** Provide a description of the initiative, project, or activity to be supported with this funding. The project description should describe:
 - The project's primary target audience;
 - How the proposed project will address climate and health priorities within the community using relevant data, if available; and
 - How the project will build upon previous work, and/or how the project will be used to support work beyond the scope of this funding period.
 - Please note: Distribution of supplies, incentives, or resources must be integrated with educational programming. Proposals should demonstrate how they will combine outreach with substantive educational activities (e.g., presentations, trainings, skill-building sessions, communications campaigns, etc.) to create a more comprehensive approach.
- **Collaboration (25 points):** Include information on how internal and/or external partners will be involved with carrying out the proposed project.
 - Applicants that identify and engage at least one community-based organization (CBO) as a primary project partner will be given priority consideration (e.g., a CBO you may have



identified as part of the 2024-2025 LHD Performance Incentive Program). Please include the name of the CBO and describe their role in project implementation.

- *We have broadly defined a CBO as: a non-governmental, community-rooted entity that engages directly with local residents to improve health, equity, and resilience. They often focus on serving and engaging vulnerable or underserved populations such as older adults; individuals with disabilities or chronic health conditions; low income residents; communities of color; immigrants and refugees; unhoused individuals; veterans; people who use drugs; and other populations disproportionately affected by climate change and environmental hazards. CBOs bring essential local knowledge, trusted relationships, and culturally responsive approaches that complement and extend the work of LHDs through locally tailored, community-driven strategies.*
 - A letter of support from the partnering CBO is strongly recommended.
- **Climate Justice (10 points):** Describe how the project will address social, racial, and/or environmental impacts that disproportionately affect the health of vulnerable populations.
- **Evaluation (15 points):** Describe how the applicant will demonstrate how the project made an impact on the community.

Optional Webinar: 2025 Climate and Health Adaptation Projects

NYSACHO will host a webinar on **Thursday, November 13, 2025 from 1-2 PM** featuring local health departments that previously received climate and health adaptation funding from NYSACHO. Requirements

By July 31, 2026, selected applicants will be required to:

- Participate in three (3) check-in calls with NYSACHO and NYSDOH.
- Develop a summary project presentation that could be presented to other LHD partners during a future webinar, summarizing the project, best practices, and lessons learned.
- Complete a project evaluation at the beginning of the project to identify anticipated outcomes, challenges, stakeholders, etc. An evaluation template from prior funding cycles is provided in Appendix C.
- Save receipts for purchases made using project funds. Receipts should be made available upon request from NYSACHO or NYSDOH.

By August 28, 2026, selected applicants will be required to:

- Complete a project evaluation at the completion of the project detailing actual challenges, outcomes, stakeholders, etc. An evaluation template from prior funding cycles is provided in Appendix C.

To ensure materials developed through this project are consistent with the positions of the NYSDOH, it is strongly recommended that materials be shared with NYSACHO & NYSDOH for review prior to publication.

Ineligible Expenses

Funds can't be used to:

- Purchase or plant trees, air conditioning units, heat pumps, air purifiers, other equipment, food, or gift cards
- Deliver medical services or purchase medical supplies
- Build permanent structures
- Support activities funded by another grant source, but may be used to supplement by enhancing or expanding upon existing grant-funded activities.

Method of Payment

NYSACHO will disburse payments to awardees via a one-time payment.

Appendix B: Examples of Climate and Health Adaptation Projects

Project funds can be used to supplement or support ongoing climate and health initiatives or be used to fund a pilot project or campaign. Listed below are examples of how this funding could be used:

- Convene a meeting with local climate and health stakeholders to advance adaptation planning. This could include broader activities (e.g., coordinating plans for future adaptation work or Climate Smart Community actions) or more specific efforts (e.g., increasing awareness of heat risks and OTDA cooling benefits among vulnerable populations, or NYSEDA energy efficiency programs)
- Develop and distribute educational materials that emphasize locally relevant health impacts of climate change, using data to tailor messaging to at-risk populations
- Host a tabletop exercise to test and evaluate response plans for climate-driven events such as flooding, extreme temperatures, or severe weather
- Organize a community event focused on environmental cleanup or Earth Day celebrations, with long-term engagement strategies to promote sustainability
- Formalize plans or improve infrastructure for local cooling and/or warming centers to better serve vulnerable residents during extreme weather events
- Purchase incentives for research or focus group participants to gather data that informs climate adaptation and public health strategies
- Increase awareness of heat-related risks and effective mitigation strategies for populations vulnerable to extreme weather events, especially extreme heat [examples could include integrating climate-related resources into existing programs (e.g., Healthy Neighborhoods Program), working with community partners to increase awareness among outdoor workers, etc.]
